




AGC Cares In Action!

2020-2023 Statewide Transportation Improvement Plan (STIP)

In July, the SDDOT held public meetings in Aberdeen, Mitchell, Rapid City, Pierre and via webinar to present the Tentative 2020-2023 STIP and to receive public input. The meetings began with SDDOT presentations pertaining to funding, the overall STIP development process and project updates. Key excerpts from the SDDOT presentation are shown below.

- The current Federal Highway Bill (FAST ACT) expires on September 30, 2020. The FAST Act provides \$310M annually for South Dakota. In 2020, the SDDOT also anticipates receiving another \$40M in federal grants. These funds are generated by the Federal Motor Fuel Tax (\$0.184/gallon for gasoline and \$0.244/gallon for diesel fuel). South Dakota is a "donee" state, receiving back over \$2 for every \$1 paid in to the federal government. Federal funds comprise a large part (70%) of SDDOT's construction budget.
- The State Highway Trust Fund provides an anticipated \$155M annually. The main revenue sources are the State Gas Tax (\$0.28/gallon) and 4% Motor Vehicle Excise Tax.


- The Tentative 2020-2023 STIP anticipated total funding is \$505M for 2020, compared to \$440M in 2019.
- Based on the Tentative 2020-2023 STIP, bridge condition will remain relatively constant but the pavement condition will decrease moderately over time.

During their September meeting, the SD Transportation Commission reviewed the public comments and approved the final STIP. More details and the final STIP is available on the SDDOT website. https://dot.sd.gov/projects-studies/planning/stip.

AGC's Construction Career Academy wrapped up its second season in Sioux Falls with a graduating class of 19 students. A collaboration between AGC of SD and Southeast Tech, high school students completed a 10-week program that combines classroom, lab and on-the-job experience in order to submerge and excite students about the construction industry. Extremely successful over the past two years, the statistics speak for themselves:

- 15 new students enrolled this year 14 graduated.
- Six 2nd year students enrolled this year five graduated.
- 1 of the 10 students from the first year has become employed with their sponsor contractor.

Plans are in motion to launch this program in Rapid City for the summer of 2020 in partnership with Western Dakota Tech. In addition, Letters of Intent have been submitted to both the South Dakota Department of Labor for a \$50,000 contract to expand the program as well as with the John T. Vucurevich Foundation in Rapid City.

LATI Stretch the Millions Scholarship Luncheon

AGC was pleased to attend LATI's Stretch the Millions Scholarship luncheon this Fall. This is the fourth year AGC has partnered with LATI to provide a full-ride Build Dakota scholarship to a student. In all, 109 LATI students received a full-ride Build Dakota scholarship for the 2019-2020 school year. AGC's chosen recipient is Isaac Engebretson from Watertown. Isaac is pursuing an HEO degree and will graduate in Spring of 2021. AGC's 2018 recipient Dylan Alexander also attended the event and will be graduating in Spring of 2020 and is planning on seeking employment in the Rapid City area following graduation.

CDL Classes at Southeast Tech – Classes Continue in January



Sixteen students have enrolled in the classes since July.





LEGISLATIVE

Reduced Rate Tax Table Triggered for Unemployment Insurance in 2020

Employers who pay into unemployment insurance will be able to use the reduced rate tax table (schedule B) for calendar year 2020. Legislation passed in 2017 established a formula to keep the Unemployment Insurance Trust Fund from growing too large by offering employers contribution tax breaks when the trust fund is at a certain level on June 30. That level was met in 2019, triggering the use of the reduced tax table for 2020. Also, due to legislation passed in 2018, a further reduction in the contribution tax rate table will be available January 1, 2020. AGC supported the legislation that led to tax rate table decreases.

CONPAC Annual Meeting - Tuesday, November 26

Make plans to attend the Annual CONPAC Meeting November 26 at 11:00am CT via conference call. Lots of activity will happen and the construction industry will be involved to shape the outcomes. First, each of the 105 legislative seats will be up



for grabs. Candidates are beginning to announce their candidacies and their campaign petitions are due in January 2020. CONPAC will discuss if any candidates need support in the June primary elections and will also make decisions on campaign support for the general election in November 2020.

CONPAC will also discuss possible ballot measures on the 2020 ballot. Twenty-three ideas were submitted and only six of them were approved by the Secretary of State for circulation. Of those six ideas, only two were submitted prior to the due date:

- Legalizing marijuana for medical purposes.
 Supporters have announced that they have secured 32,000 signatures, which is double the number needed (16,961 valid signatures). This group has made similar claims in the past and has come up short when the Secretary of State validates the petitions.
- Legalize marijuana (15% excise tax on marijuana and require hemp regulations by SD). This proposed ballot measure is being circulated by paid circulators who are actively collecting signatures. Number of signatures needed is 33,921.

RECORDS RETENTION

Thanks to the AGC HR Alliance for allowing me to present on the topic of records retention. The presentation focused on the Sedona Guidelines for Managing Information & Records in the Electronic Age (2007). These guidelines are part of the Sedona Conference, which is quickly becoming the gold standard



for a number of subjects that are at the crossroads of electronic information management and legal obligation. More information about this organization and its various work groups and publications is available at https://thesedonaconference.org/.

The Sedona Guidelines do not take a one-size-fits-all approach to records management. It does not provide a list of which records to keep and which to disregard. Rather, the guidelines present an approach to creating your own guidelines, recognizing that every situation is different, and reasonableness should be the hallmark of every policy. If your organization does not have a formal records retention policy, these guidelines are a good primary resource for considering why such a policy may be needed for your organization and how to go about creating your own policy.

Senate Approves FY 2020 Transportation Funding - Transit Funding Cut Addressed

The Senate just approved a package of four appropriations bills including its version of the FY2020 funding package for US DOT programs. The Senate bill, like the House bill passed



in June, includes the full \$46.365 billion FAST Act obligation limitation for the federal-aid highway program, a \$1.1 billion increase over 2019. In addition, the bill includes a supplemental \$2.7 billion discretionary appropriations for highway programs and an additional \$560 million for transit grants (see chart below). Since none of the 12 FY 2020 appropriations bills were signed into law by the end of FY 2019, government programs including those of US DOT, have been operating under a Continuing Resolution that funds programs through November 21 at the FY 2019 level. It is likely that a compromise DOT funding bill can be approved before November 21 with the increased funding levels. While the Senate bill fixes a budgetary limit provision that, if left unaddressed, could lead to a 12 percent acrossthe-board cut in transit formula grants from the levels authorized in the FAST Act, it did not address a pending \$7.6 billion rescission in highway contract authority.

U.S. Department of Labor Issues Final Overtime Rule - Sets Salary Threshold of \$35,568 per year


In September, the U.S. Department of Labor (DOL) announced a final rule updating the earnings thresholds necessary to exempt executive, administrative, or professional employees from the Fair Labor Standards Act (FLSA) minimum wage and overtime pay requirements and allowing employers to count a portion of certain bonuses (and commissions) towards meeting the salary level. The final rule includes many of AGC's policy recommendations.

AGC Makes Case for Expanding OSHA's Silica Standard Table

In October, AGC and coalition partners made the case to the U.S. Occupational Safety and Health Administration (OSHA)—in response to the agency's request for information—to include more
