



AGC Infrastructure/Utilities Meetings







COVID-19 & MSHA

During the COVID-19 Pandemic, the Mine Safety and Health Administration (MSHA) has stated it will continue to carry out its stated mission to protect the safety and health of the nation's miners. MSHA will continue to perform its essential functions within the parameters of the President's and Department's guidance, as well as that of the Centers for Disease Control and Prevention (CDC) as long as miners continue to work at a mine.

For the duration of the President's national emergency declaration, MSHA has suspended Educational Field and Small Mine Services visits, as well as special safety and fatality initiatives that normally would gather groups of miners on-site. MSHA will work with mine operators when it comes to some recertifications such as Annual refresher training certification. MSHA will not grant exemptions to recertification's; but their due dates will be extended by at least the time the government is operating under the emergency declaration. However, this exception does not apply to new miner training. New miners must be trained before beginning work. While you focus on COVID-19 precautions, don't focus solely on that and forget about all other safety and health provisions for our miners.

CDL Training

The AGC of South Dakota currently does not have any upcoming classes scheduled. Once our Training Consultant returns to training, we will put dates out for the membership. If you have employees who have their permits and need to take the Ride Along and Pre-Trip Inspection portion to get their licensing, the information for 3rd party testing is available at www.sdagc.org.

It's election year in South Dakota! All 105 legislative seats are up for election. Starting with primary elections in June and ending with the general election in November, CONPAC will work to elect business-



Unemployment Insurance Claims Skyrocket



Possible Special Legislative Session

State revenue sources, such as sales and use tax and video lottery revenue, have plummeted since COVID-19 related shutdowns. State legislators and the Noem administration have been discussing the possibility of a special session of the South Dakota Legislature in June to address revenue shortfalls and the use of possible COVID-19 relief revenue from the federal government. If a special session is called, everything in the 2021 budget passed in March is subject to change to stop the budgetary red ink. This would include the \$28 million in local road funding in the general budget for 2021. If a special session is called, AGC will be there to promote and protect highway funding.

THE CONTRACTOR WINS


The South Dakota Supreme Court recently issued an opinion with some significant

implications for contractors, Excel Underground, Inc. v. Brant Lake Sanitary Dist., 2020 S.D. 19. The project in question involved the installation of a sewer system. After lengthy delays, the owner terminated the contractor and thereafter both parties sued for breach of contract. The contractor prevailed at trial and the Supreme Court upheld the verdict. The significant rulings are as follows:

- 1. When the owner of the project terminated the contract, it sued for both liquidated damages and compensatory damages. A prior court decision had already established that a party that chooses to take over a project cannot then seek an award of liquidated damages. Rather, it must seek an award of actual damages based upon the extra costs incurred. The owner argued that the cost to complete was a different type of damages from the costs associated with delay, but the court declined to reconsider the established precedent because the jury had ruled against the owner on liability in any event.
- 2. The court also considered whether it was appropriate to instruct the jury that the project engineer had acted as the agent for the owner and that any acts by the engineer were to be considered the acts of the owner. At trial, the contractor pointed to the engineer's deficiencies during the performance of the contract as evidence of the breach of contract. The owner argued that the engineer was an independent contractor and that it could not be liable for the acts of an independent contractor. The trial court's instruction to the jury on the issue were confusing. but the court found no error because the facts were that the engineer was the owner's contract representative and as such had authority to act on behalf of the owner.
- 3. The court also upheld the award of damages by the jury including an award of lost profits based

as consequential damages. Generally, lost profits may be recovered for both direct and consequential damages. To recover consequential damages they must be reasonably foreseeable at the time of the contract, and they must not be speculative. The owner argued that it was speculative to award profit based upon lost profits from future contracts, but the court upheld the award. In doing so, it pointed to the testimony of the contractor's expert witness, a CPA, who testified as to the loss of bonding capacity experienced as a result of the owner's breach. The contractor presented evidence of its history of public contract awards. The expert witness testified as to the contractor's tax returns and financial statements. The court upheld an award for lost profits of \$800,000.



This final rule establishes the scope of federal regulatory authority under the Clean Water Act. After a multi-




AGC Bids Farewell to Highway Division Director Brian Deery
