The Good Citizen Award is awarded in recognition of those people in our industry who, by their action and by their service, accomplish meritorious deeds. These will be singular achievements, which bring credit to the individual or their firm and thereby improve the image of the construction industry. The award will not necessarily be presented annually. Award nominations must be submitted by the deadline shown on the enclosed Nomination Form, with presentation to be made at the State Convention and one or both of the Spring Membership Meetings. The award criteria listed below are intended only as a guideline to create awareness of the general parameters of this award.

Individual Recognition – The Good Citizen Award recognizes meritorious action or service by an individual.

Within or Outside the Industry – The exemplary achievement may be related to construction or may have been accomplished outside of normal industry activities. The key is whether the action, directly or indirectly, brings credit to the individual or their firm, thereby improving the image of our industry.

Public or Private – The recognition may be for some action or service which “makes the news” – a noteworthy public event. However, the award may also recognize an activity which has occurred without public knowledge or scrutiny.

Immediate or Long-Term Impact – The action deemed worthy of a Good Citizen Award may have been performed at an accident, disaster or other incident and brought immediate impact. However, an individual may have also caused long-term positive results through service on a board, committee or by other community service.

Beneficiaries of Action or Service – Possible recipients of meritorious deeds are numerous. They include individuals in need, communities, charities, churches, hospitals, fraternal organizations and governmental agencies.

Any AGC of South Dakota member may nominate an individual for the Good Citizen Award. All nominees must be affiliated with an AGC member firm. All nominations must use the enclosed Nomination Form, which may be accompanied by a separate one-page narrative.
